



Giving to Ashbury: Important Information for Residents of the USA

As Ashbury College cannot issue American tax receipts, we recommend that residents of the United States who wish to make a philanthropic gift to Ashbury make a tax-deductible contribution to FRISBE and request that it make a grant to Ashbury on your behalf. If you prefer to donate to Ashbury directly, note that your gift will be receipted with a Canadian tax receipt.

About FRISBE: The Friends of Independent Schools and Better Education (FRISBE) is a non-profit, tax-exempt corporation established in 1982. FRISBE facilitates contributions from US residents to quality Canadian educational institutions, including Ashbury. FRISBE forwards grants to Ashbury twice a year, usually in March and September, and Ashbury will record your donation in Canadian funds. There is no fee for FRISBE’s service and 100% of your gift will be sent to Ashbury, as requested.

Tax Status of Gifts: The United States Treasury Department, Internal Revenue Service, includes FRISBE in its “Cumulative List of Organizations” described in section 170(C) of the Internal Revenue Code which are exempt from Federal Income Taxes under section 501(C)(3) of the Internal Revenue Code. Contributions and gifts to FRISBE are deductible for Federal Income Tax purposes to the full extent permitted by law. FRISBE Federal Tax No. 91-1216755.
